1. This promotion is being conducted by Deanside Constructions Pty Ltd ("Promoter") of Suite 11 / 860 Doncaster Road, East Doncaster, VIC, 3109.
2. The promotion commences at 9am (Melbourne time) on October 1, 2023 and ends at 5pm (Melbourne time) on December 31, 2024 ("Promotional Period").
3. In these terms and conditions, a referrer is a person aged 18 years or over who provides their friends' or family members' contact details to the Promoter ("Referrer") and the referred person is the person referred to the Promoter by the Referrer.
4. A Referrer will be entitled to \$1,000 payable via a pre paid visa card ("Reward") if:
  - (a) the Referrer has completed the Promoter's approved promotion application form and returned it to a sales consultant in respect of the Promoter's project named 'Deanside Village' located at Deanside ("Deanside Village at Deanside");
